MINUTES OF HEARING SESSION

On the twenty seventh day of January of the year two thousand and fifteen at fourteen o'clock, in the Hearing Room of the 5th Court of the judicial section of Piauí, located in the main building, at Av. Miguel Rosa, n ° 7315 - Neighborhood: Redenção Teresina-Pi - Zip Code: 64018-55Q/phone: (86) 2107-2800 / 2801, present the Hon. Federal Judge of the 5th Court, Dra. MARINA ROCHA CAVALCANTI BARROS MENDES, alongside, the Judicial Technician, hereinafter nominated, at the appointed time, the present hearing session was declared open.

, After the proceeding had begun, Hon. Federal Judge heard the parties involved, in the following order: Rosângela A. Barros Curado - Executive Secretary of Health of the State of Maranhão; Marcos Elizeu Marinho Oliveira - Ministry of Health/SAS/ARAC; Aderivaldo Coelho de Andrade - City Health Secretary of the City of Teresina; Francisco de Assis de Oliveira Costa - Secretary of Health of the State of Piauí; Kelston Pinheiro Lages – Federal Prosecutor; Rogena Ximenes Viana – Union Public Defender; Alysson Gardanny Novaes Silva - Oncology Regulation - MA; Marina do Nascimento Sousa - Control, Evaluation and Regulation - MA; Ivaldo Carneiro Fontenele Júnior - Prosecutor of the City of Teresina, Egidio de Carvalho Ribeiro - Regulation Sector of Maranhão; Erls Martins Cavalcante - Prosecutor of the State of Maranhão; Romero Lucas Rangel Piccoli – District Attorney of the State of Maranhão in Caxias.

All duly registered by voice and image recording system, with the recording media on the records, with the parties being entitled to reproduce the recording on a CD or pen drive.

In the end, it was concluded that there are problems of two orders to be overcome. The first is organizational, to be overcome through documentation of installed capacity and flow of patients and payments. In this sense, it deserves to be noted that the installation and operation of the of oncological patients' regulation in Maranhão and Piauí has occurred. The

second problem is structural, which needs to be enlarged, to meet the existing demand in Piauí and Maranhão.

In view of these two references of action now determined, **ORGANIZATION and STRUCTURE**, **the parties agreed to comply with the following SCHEDULE:**

1) Time limit of 30 (thirty) days for the State of Piauí and the State of Maranhão to install a COMPENSATION CHAMBER, in which are formalized: the offered capacity, the payment transfer agreements, as well as the flows and dates. At the end of mentioned time limit, the City of Teresina shall attach the respective supporting documents to the case file. Once the requirement has been met, the Federal Government shall pay the second installment of the undertaken debt in 2013, in the total amount of R\$ 8,000,000.00 (eight million reais).

2) Time limit of 30 (thirty) days for the State of Piauí and Maranhão to resolve the consubstantiated pending matters embodied in Notification Letters No. 307 and 310/2014-CGAPDC/DAET/SAS/MS, addressed to the State of Maranhão; and Notification Letters No. 289 and 311/2014-CGAPDC/DAET/SAS/MS, addressed to Piauí.

3) The third installment of the total amount of R\$ 8,000,000.00 (eight million reais) shall be paid through the preparation of the pactuation integrated programming-PPI of the two States. Therefore, the Federal Government shall, as of February, make a technical team available to collaborate with the States of Piauí and Maranhão.

4) It is designated a hearing session for the purpose of dealing with the opening of the oncology service of the University Hospital, set for **February 26, 2015, in this Court Room at 9 o'clock in the morning**. To do so, hereby is summoned Dra. Patricia Chueri, the National Coordinator of Oncology Service of the Ministry of Health, Dr. José Miguel, Director of the University Hospital, Dr. Carlos Eduardo, auditor of DENASUS, and also the representative of EBSERH, in Brasília. Proceedings by the Secretary.

5) The present parties are considered summoned.

Proceedings by the Secretary, including the Federal Public Prosecutor's Office subpoena for attendance to the designated hearing.
